"We bill in advance for our services, so we need to properly account for deferred revenue," explains Weinstein. Then the development team at ADSS Global was able to modify the software to handle our unique deferred revenue billing requirements."

The company generates more than 1,000 invoices each month, the majority are sent by e-mail to customers directly from Sage Accpac ERP.

ADSS was able to migrate Health Advocate's data from QuickBooks to Sage Accpac ERP, saving hours of data entry and allowing the staff to be productive right from the start.

There are even instances where a commission is split between agents," says Masci. "ADSS Global did a great job of customizing the software to meet our specific needs."

Previous to implementing Sage Accpac ERP, Masci and Weinstein have developed an elaborate system in Excel to accommodate the company's complex financial statements. In the past, summarized data from QuickBooks was manually entered into Excel each month, and deferred revenue was calculated manually, line by line. It was a tedious, time-consuming process. Now, relevant data is exported from Sage Accpac ERP and imported into Excel. This saves time, increases accuracy, and facilitates a streamlined reporting cycle.
